- 2. SUBMIT a COMPLETED PARKING APPLICATION, SIGNED BY A PARENT
- 3. MUST SHOW AND SUBMIT A COPY OF YOUR ORIGINAL DRIVER'S LICENSE AND CAR REGISTRATION
- 4. MUST HAVE COMPLETED a DRIVER'S EDUCATION COURSE and a CERTIFICATE OF COMPLETION MUST BE SUBMITTED IF <u>TAKEN OUTSIDE</u> OF THE DISTRICT
- 5. MUST HAVE COMPLETED DRIVER'S SAFTEY CLASS & PROOF OF COMPLETION NEEDS TO BE SUBMITTED IF <u>TAKEN OUTSIDE OF THE</u> DISTRICT
- 6. <u>IF YOU MEET ALL OF THESE REQUIRMENTS YOU MAY PARTICIPATE IN</u>
