furtherance of federal, state, and local mandates to limit any and all public gatherings. As authorized by Governor Andrew M. Cuomo's Executive Order No. 202.1, issued on March 12, 2020, and as extended by subsequent Executive Orders, this meeting is being held remotely by videoconferencing and the public will not be permitted to attend the meeting in-person. The Board of Education will make a motion setting forth the manner in which the meeting will be conducted and waiving any applicable policies or common practices with respect to the conduct of the meeting. The public participation portion of the meeting will be suspended. The meeting will be video broadcasted in order to provide the public with the ability to view the meeting. This meeting will also be recorded and later transcribed in accordance with Executive Order 202.1, as extended.

Board President's Comments

Ms. Ben-Levy made the following comments: "This Board and I personally have never ever been prouder of our school Administration and of our staff in how hard they have worked and how diligently in their efforts since March 13, 2020 with the onset of this unthinkable public health emergency. For that, we commend them, we ask them to please redouble their efforts to make sure that every child, every Roslyn child, is protected and every Roslyn staff member is protected in terms of health, safety and security first and foremost and is educated in the Roslyn brand according to the hallmarks that we have always been so proud of. Allison Brown is our Superintendent and our instructional leader. I have never been prouder of a colleague in any setting then I am of you, and of your leadership, and of that of your team. I thank you from the bottom of my heart as a board leader, as a corporate governance team leader, as a community member, as parent and as a colleague. I thank you for your effort. I am speaking not just on my own behalf, but on behalf of the entire seven member Board of Education who each shares in my sentiments."

Superintendent's Comments

Ms. Brown thanked Ms. Ben-Levy and made the following statement: "As you know, we are working to put together a platform for the reopening options of school. As the Board knows, we plan to put our plan together based on input from surveys from families, students, teachers and conversations that we have had. I want the Board to understand and certainly, the community, we will be going through this in great detail at our meetings moving forward. The District needs to submit to the State assurances that our plan will meet the State guidelines. I want the Board and the community to understand that nothing is written in stone, nor could anything ever be written in stone. We are dealing with children and families, so we must always be

flexible. The plan will and can change based on the circumstance and input from our students, our teachers and our community. I think that is very important as there seems to be a misunderstanding that as of today, whatever plan we submit is written in stone."

Ms. Ben-Levy commented: "On behalf of the Board of Education, I know that things are changing minute to minute, your assuring based on guidelines that are changing minute by minute and the governor of this State has yet to determine what it is that will be possible. When we hear from the governor, we will then know and we will continue to malleably and nimbly adjust what we are doing going forward. I would be remise not to thank everyone in our community for their cooperation and leadership, not least of all the Roslyn teachers association and the Roslyn teachers leadership. They are our life's blood and leadership especially in this moment.

Ms. Brown spoke of how proud she is of the Roslyn Teachers Association team and for their support. Approximately 175 members of the teachers association attended a faculty meeting on July 30, 2020 to plan for the start of school. In addition, Ms. Brown commented on feedback she has received from concerned parents regarding the hybrid model. The parents number one concern is on the day students are not in the classroom – are students going to sleep all day, how are we going to get the kids up, who's going to make sure they have to be somewhere. Ms. Brown spoke of the family school connection and the support the families need: to help them to put their kids on a schedule, to get them up, to have accountability. She said this would be part of the plan developed to support the students and families. In return, Ms. Brown needs families to support the schools by taking your child's temperature each day and not sending sick children to school.

Ms. Brown acknowledged Eleanor Russell, President Roslyn Teachers Association, and thanked her for support in working together on the plans for the start of school.

Ms. Ben-Ley commented on the importance of the home school partnership, "which has been the hallmark of the strength of the Roslyn education." She spoke of the importance of communicating information between the home and school concerning the opening of schools. Ms. Ben-Levy reminded the community if parents need support and assistance the district has a full complement of school psychologist, school social workers, school guidance counselors and others that can help.

Ms. Brown expressed her appreciation for the support she has received and spoke of the need to support each other during this pandemic.

Ms. Ben-Levy emphasized that every Roslyn child and parent deserves the best that the Roslyn School District can offer which has been the hallmark and strength of the district and it will continue to be.

Ms. Ben-Levy ended her comments with the following statement: "This is going to be a difficult year. Schools not going to look to same, school not going to feel the same,

schools not going to be the same for anybody at any level. Regardless of what people seem to be doing right now outside the school buildings. Things are going to change and it will not be to everyone's liking. No matter which way we go. No matter with what decisions get made, people are going to have to manage their expectations. Not just in Roslyn but everywhere on the globe. This is a public health emergency of epic proportion and nobody anywhere has the answers. We are going to do more than most, because that's who we are. But it's still not going to be perfect and it's never going to be what is in our traditional legacy program, but what they're going to have are traditional Roslyn people and traditional Roslyn values and with that you are going to have traditional Roslyn yeoman's effort in everything and that's all everyone can ever ask."

RESOLVED, that the District Clerk of this School District is hereby authorized and directed, pursuant to Section 6-20.0 and amendments thereto of the Nassau County Administrative Code, to file a certified copy of these resolutions with the Nassau County Legislature and the Department of Assessment, Mineola, New York, on or before August 17, 2020.

[Note: Based on <u>tentative</u> Class 1 assessed values as of April 1, 2020 of \$5,038,817 (which will be finalized by the Nassau County Assessor) and <u>uncertified</u> Class 1 base proportion of .8176714 (which will be calculated by the Nassau County Assessor and certified by the Nassau County Legislature) the <u>estimated</u> tax levy in Class 1 (residential) for school purposes will be \$79,135,279 (an increase of 1.83%) and for library purposes will be \$4,140,990 (an increase of 0.52%) resulting in <u>estimated</u> tax rates of

\$1,570.513 per \$100 of Assessed Value for school purposes and \$82.182 per \$100 of Assessed Value for Library Purposes.]
