Board President's Comments

Ms. Ben-Levy commented on the NYSSBA Pre-Convention Law Conference she attended virtually October 21 and 22. She thanked NYSSBA and the school attorneys for presenting a very informative conference.

Ms. Ben-Levy remarked on how well she believes "the Administration, Staff, Faculty, Students and Parents are doing as we navigate these very new waters with this coronavirus." She spoke of how proud she is of the community and the District's leadership. Ms. Ben-Levy expressed her admiration for the members of the Board of Education and she thanked them for their sacrifice and service for the children of Roslyn.

Superintendent's Comments

Board of Recognition Week

This evening members of the Board of Education were recognized for their outstanding support of the Roslyn Community: Ms. Brown read the following statement:

"Roslyn is joining public school districts across the state to celebrate School Board Recognition Week—October 19-23, 2020. The week was created to honor local board

members for their commitment to education and to promote awareness and understanding of the important work they perform.

"The members of the Roslyn Board of Education (BOE) devote countless hours to making sure our schools help every child learn at a high level. "Throughout the year, they make tough decisions on educational and financial issues. These past few months, they have gone above and beyond to ensure that all of our schools continue to be safe environments for learning, while providing the kind of accountability our community expects."

The fundamental work of any school board is to create a shared vision for the education of a community.
