


ANTICIPATED GRANTS

BUDGET-TO-BUDGET

- Budget-to-budget increase is presently at 3.98%; we continue to sharpen our pencils
- After careful consideration and review, we were able to remove items that we felt were important but not critical to our program at this time
- Reflects and supports the BOE goals
- All budget administrators take an active role in fine tuning their budgets
- We continue to provide an outstanding educational experience despite the increasing inflation, higher enrollment, lower state aid, and unfunded mandates

2% IS NOT REALLY 2%

- Inflation is between 2% and 3% compounded on top of the 4.12% increase from the prior year
- The tax cap growth factor is limited to only 2.0%...but exclusions change that number
- The increase will bring our levy limit higher than 2%

2 YEAR STATE AID COMPARISON

2024-2025	2025-2026
State Aid - \$249,102 increase (2.24%)	State Aid - \$305,162 DECREASE (-2.69%)*

Budget increase has to be funded with a decrease in State Aid

*State Aid increase will be reported by the State as \$194,802 which includes <u>UPK</u> funds that <u>pass through</u> the District
