A MESSAGE FROM THE BOARD OF EDUCATION

Dear Roslyn Community,

On behalf of the Roslyn Board of Education, I am pleased to present the proposed 2025-2026 school budget, a financial plan that reflects our steadfast commitment to academic excellence, student well-being, and fiscal responsibility. This budget ensures continued outstanding educational opportunities while maintaining a stable financial outlook.

Our spending plan prioritizes student success and innovative programming, with investments in curriculum and instruction that include an expanded focus on artificial intelligence, business education, STEM initiatives, as well as enhancements in reading and writing programs. We are proud to offer new contemporary courses found nowhere else—like Foundations of Business and Applied Mathematics, Grammar Fundamentals, and Pre-Veterinary Science. We continue other visionary opportunities like Pre-Med, our EV Lab, Hydroponic Garden, Incubator, Accelerator, and Investment's Lab, along with continued support for our world-class Fine and Performing Arts, Athletics, and Co-Curricular programs, all of which are designed to uniquely enrich our students' learning experiences to open and enhance their pathways forward.

This budget builds on the successes of the past year, ensuring that our facilities and technology support modern education. We have allocated funds for critical infrastructure upgrades—including improvements to the high school auditorium and the construction of a Harbor Hill baseball field, as well as our HVAC systems and security cameras. A significant technology refresh will update district-wide computers, interactive displays, and communication systems to foster a more connected and dynamic learning environment.

While state aid has decreased, we remain steadfast advocates for our community. Our necessarily strategic approach to budget adjustments allows us to maintain a budget-to-budget increase of 3.2% while keeping the tax levy increase at 2.89%, within the allowable limits.

We invite you to review the full budget and participate in the upcoming budget vote on **May 20, 2025**. Thank you for your continued partnership in ensuring a bright future for our children.

2025-2026 PROPOSITIONS

PROPOSITION 1

BE IT RESOLVED that the proposed budget of expenditures adopted by the Board of Education of the Roslyn Union Free School District for the 2025-2026 school year in the amount of \$136,811,323 be approved, and the amount thereof shall be raised by a levy of a tax upon the taxable property of the school district, after first deducting the monies available from State Aid and other sources as provided by law.

PROPOSITION 2

BE IT RESOLVED that the proposed budget of the Bryant Library in the amount of \$5,302,534 as prepared by the Trustees of said Library for the 2025-2026 school year and that the amount of \$5,302,534 be raised by the levy of a tax upon the taxable real property in the Roslyn Union Free School District be and hereby are approved.

PROPOSITION 3

Shall the Board of Education be authorized to (a) purchase various school buses and vans for use by the District, including related equipment and apparatus, and to expend therefor, including preliminary costs and costs incidental thereto and to the financing thereof, an amount not to exceed the estimated total cost of \$719,746 (b) that a tax is hereby voted in the aggregate amount of not to exceed \$719,746 to pay such cost, said tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the principal amount of not to exceed \$719,746 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable, and (d) that, in lieu of bonds, the District is authorized to enter into one or more installment purchase contracts for the purchase of some or all of said buses and vans, for a term not to exceed five (5) years; and a tax is hereby voted to pay each installment on any such contract.

2025-2026 BUDGET HIGHLIGHTS

- Launch K–12 offerings that will tap imagination and creativity to introduce innovative, future-ready courses for all students
- Expand AI Decodable Story Creator to Grades 1 and 2, supporting early literacy through Science of Reading principles
- Implement ELA Writing Curriculum aligned with the Science of Reading to strengthen foundational writing and literacy skills
- Introduce the Khanmigo AI Support Tool to enhance instruction and streamline classroom workflow with AI-powered teacher assistance
- Embed AI ethics and machine learning into the AI & Technology Curriculum
- Integrate real-world business concepts with applied math in Foundations of Business and Applied Math
- Require all 8th graders to take Grammar Fundamentals 8, a course that ensures mastery of grammar, punctuation, and writing conventions
- Offer hands-on learning in veterinary science using Anatomage technology and Cornell curriculum for real-world experience
- Empower students through iPeer Coaching to support peers with disabilities in Adapted PE, building leadership, inclusion, and empathy
- Advance student storytelling with Podcasting 3.0, an in-depth audio production course featuring longform narrative creation and leadership roles
