Please provide all the proof required even if your child is currently receiving transportation provided by the school district.

If you own your home, you must present a mortgage bill and a utility bill. If you rent, you must present a rental agreement notarized by you and your landlord, as well as a utility bill.

If you are new to the district or changing from public school to private school, additional information need to be submitted, please contact the Transportation Office at 516 801 5190

All residents of the Roslyn School District requesting transportation to non-public schools for their children **MUST** submit this application to be eligible for the **2020-21** school year. Proof of residency in the Roslyn School District **MUST** be submitted for **ALL APPLICATIONS EVERY YEAR**. A copy of a birth certificate **MUST** also be submitted for all kindergarten children, all children who change from a public school to a private school, and all children regardless of age who are new to the school district.

The maximum distance a child can be transported is 15 miles.

INSTRUCTIONS: Please answer all questions on this transportation request form and return it in an envelope to the Roslyn Public Schools, P.O. Box 367, Roslyn, New York 11576, Attention: Transportation Office, **before APRIL 1, 2020.**

We strongly recommend that, if you are filing after **March 1, 2020**, either **hand deliver** the form or send it by **certified mail**. **WE DO NOT ACCEPT FAXES.** Please submit **ONE FORM PER STUDENT** requiring transportation, including those for whom you have submitted a school application but have not yet received acceptance. A confirmation letter will be sent to acknowledge receipt of your transportation request application.
