Proof of residency in the Roslyn School District <u>MUST</u> be submitted for <u>ALL APPLICATIONS EVERY YEAR</u>. A copy of a birth certificate <u>MUST</u> also be submitted for all kindergarten children, all children who change from a public school to a private school, and all children regardless of age who are new to the school district.

#### The maximum distance a child can be transported is 15 miles.
