**Preliminary Announcements** 

The Roslyn Union Free School District continues to take steps to reduce the potential for exposure to the coronavirus (COVID-19). The District's efforts in this regard are made in furtherance of federal, state, and local mandates to limit any and all public gatherings. As authorized by Governor Andrew M. Cuomo's Executive Order No. 202.1, issued on March 12, 2020, and as extended by subsequent Executive Orders, this meeting is being

held remotely by videoconferencing and the public will not be permitted to attend the meeting in-person. The Board of Education will make a motion setting forth the manner in which the meeting will be conducted and waiving any applicable policies or common practices with respect to the conduct of the meeting. The public participation portion of the meeting will be suspended. The meeting will be video broadcasted in order to provide the public with the ability to view the meeting. This meeting will also be recorded and later transcribed in accordance with Executive Order 202.1, as extended.

# Ms. Ben-Levy moved, seconded by Dr. Valauri, carried by a vote of 5-0 (Messrs. Saffron and Seinfeld absent), to accept the Claims Audit Report for January 2021.

On March 3, 2021, Ms. Brown announce the first phase to bring all students back for a five-day-a-week in-person schedule. Beginning March 16, 2021 the district will offer five-day-a-week in-person learning for grades 6 and 12. The district will gradually bring in additional grades on an everyday basis, assessing the implementation plan as the district proceeds.

# **Board President's Comments**

On behalf of the Board of Education, Ms. Ben-Levy thanked Ms. Brown and the Administration for moving the district forward in the effort to bring students back to school five days per week. She thanked the staff for their cooperation in getting vaccinated. She spoke of the excitement that involves the students being able to enjoy more fully the legacy programs to the extent that they can during these challenging circumstances. She thanked Ms. Brown again and stated, "This has been a year like no other, I do see the light at the end of the tunnel, and I just want us all to get there together. Today is March 4 and so we shall march forth".

# Superintendent's Comments

Ms. Brown spoke of how thrilling it is to be moving forward. She stated, "There is nothing that we don't do without being thoughtful and measured." She thanked the teachers, administrators, support staff, custodians, maintainers and cleaners for all their efforts to bring the students back in to the schools. Ms. Brown also thanked the families for their patience and support and because of their support; the district is able to bring the students back at this time.

In addition, Ms. Ben-Levy thanked the students and the student leaders for all that they have done to keep safe and stay safe and by setting examples for the rest of the students. She spoke of the Roslyn student's that have been mentioned twice in the emails sent by Governor Cuomo in a section called "Deep Breath Moment" and other publications that have had articles in which Roslyn students have been mentioned frequently for their service to the community.

### Student Delegate's Comments

Ms. Pahlevan updated the board of the OCC activities. The OCC:

- 1) Sent valentine cards to each grade.
- 2) Established an OCC website to inform the study body of their grades activities and school events.
- 3) Created a video for the Town of North Hempstead thanking the health care workers and first responders.
- 4) Spirit week a new activity includes a Leprechaun gold coin hunt
- 5) Junior Class Dance brainstorming alternative ideas for this year's dance.

Ms. Pahlevan thanked the teachers and staff for all their help and stated "it's a team effort to get everything done".
