The **Free Application for Financial Student Aid (FAFSA)** is a form that allows students to apply for federal student aid, such as scholarships, grants, work-study, and loans for college, career/trade school, or graduate school.

### BE PREPARED

Both students and parents must provide the following:

- Drivers License Social Security Number
- Tax returns from two years prior to the
- FAFSA application year (2023) Records of other untaxed income, such as child support received, veterans' benefits, or military allowances. personal E-Mail address

### FAFSA IS A YEARLY PROCESS

Your financial aid package supports one academic year. A new FAFSA form must be completed **each year** to continue receiving financial aid
