Board of Recognition Week

This evening members of the Board of Education were recognized for their outstanding support of the Roslyn Community: Ms. Brown read the following statement:

As a token of appreciation, the Board received a photo of the Horse Tamer, which commemorates the statues recent return to the district.

On behalf of the Coordinating Council of Parent Associations (CCPA), Co-President Eva Bykov, read the following statement:

"Good evening.

On behalf of my co-president, Jennifer Disanti, our Parent Faculty Association leaders, and the parents and guardians of the Roslyn school district, I would like to express our heartfelt thanks to our Board of Education.

We appreciate your tireless work on behalf of our community. We are grateful for your dedication to our children. And we are proud of the spirit of cooperation that you model for us, the spirit that makes our school district unique among our neighbors.

We thank you for everything you do and wish you continued success in your leadership."

The CCPA provided refreshments for tonight's celebration.

On behalf of the board of education, Ms. Ben-Levy thanked the member of Central Administration, the CCPA and Staff for this year's board recognition. She spoke of the cohesive working relationship the Board has with each other and members of Central Administration, staff and greater community.

Ms. Ben-Levy commented on the wonderful rededication ceremony of the Horse Tamer. She thanked the members of the Class of 1969 and 2012, Friends of the Horse Tamer, staff and the community for all their hard work to bring the statue back to Roslyn.

Mr. Seinfeld commented on the return of the Horse Tamer statue and how the Horse Tamer represents the past and the future. The Horse Tamer had been in disrepair for a number of years. He compared the statue to the infrastructure of the district from 15 years ago and where the district is today.

Mr. Saffron spoke of the incredible support the Board of Education receives from the community. He commented on how every organization must have a great leader and this Board of Education has a great leader in Meryl Waxman Ben-Levy. He spoke of her passion in everything she does especially for the children of the Roslyn School District.

Ms. Ben-Levy thanked Mr. Saffron for his kind words and spoke of how grateful she is to have such a wonderful team of Board members to work with.

Board President's Comments

Ms. Ben-Levy thanked the CCPA for providing refreshments and the staff and students of the music department for performing at the rededication of the Horse Tamer.

Superintendent's Comments

In lieu of her comments this evening, Ms. Brown asked Mr. Dragone to speak about the recent tax rate changes imposed by the Nassau County Assessor.

Mr. Dragone presented a PowerPoint "Impact of Nassau County Assessor. Budget approved by the Voters in May vs. Tax Rate Established by the County Assessor in October".

Mr. Dragone explained the following:

The tax levy for the Roslyn School District remains at 1.97%

As of October 2, 2019, Nassau County implemented the following changes:

- 1) The portion of taxes paid by private homes Increased by .52%.
- 2) The values of homes declined by 2.44%
- 3) Tax rate increase 5.21%

Due to the decline in the value of homes and the increased tax rate, the average tax bill will now change from .44% to 2.49% an increase of more than 6 times the

estimated change.

Ms. Brown spoke of the recent Harlem Wizards fundraiser hosted by the East Hills and Harbor Hill PFA. It was a sold out event and the students had an incredible time watching their teachers play the Harlem Wizards. She thanked the PFA's for this great event.

Ms. Ben-Levy read a Nassau County Office of the Executive citation sent by Ms. Laura Curran, County Executive Nassau County to the Roslyn Public Schools to commemorate the occasion of its rededication of "the Horse Tamer" statue.

Student Delegate's Comments

On behalf of the students, Mr. Antenberg expressed his appreciation to the Board of Education for all they have done for the students of Roslyn.

This past Saturday, members of the OCC gave tours of the High School to the Class of 1969, celebrating their 50th Union. The Class of 1969 will be donating to the Horse Tamer fund.

<u>Discussion Item(s):</u>

High School Girls Locker room and Science Lab renovations

Kenneth Schupner and Gabriel Divone, Architects, BBS Architects, Landscape Architects, Engineers presented a PowerPoint "Proposed High School Science Room & Locker Room Renovations".

High School Science Lab Renovations

They had meet with Mr. Gary Ramonetti, Science Chairperson, science teachers and students to discuss the needs and wants of the science department. The proposed renovations are Physics Rooms 130, and 131, Biology Rooms 132 and 232 and Chemistry Rooms 230 and 231. Included in the renovations will be rooms 130a, 130b, 132a, 230a, 230b, 230c 231a, 232a and the greenhouse. The estimated cost of the renovations are approximately \$4.3 million.

The board entered into a lengthy discussion on the proposed furniture, the classroom and storage layout, the proposed flooring, the lead-time of the State Education Department for approval of the plans, the septic systems and the timeframe of the renovation.

High School Girls Locker Room Renovations

The proposed renovations to the girl's locker room include:

- New drop ceiling
- New Physical Education and Team lockers
- New epoxy flooring
- New doors, frames and walls
- o New fixtures, partitions, and ceramic wall and floor tiles in the toilet

area

- Expanded Coaches office and new storage room
- New light fixtures and fire alarm devices
- New HVAC unit

The renovation will include the replacement of ceiling and lighting in the wrestling room. The total cost for this renovation is approximately \$1.5 million.

Ms. Brown asked BBS Architects to attend the November 7, 2019 meeting to update the Board on their concerns dealing with the proposed renovations of the High School Science labs.
